Important Information regarding medical and nursing care available during the pilgrimage

For pilgrims applying to stay in the Accueil Notre-Dame

Pilgrims applying to stay at the Accueil Notre-Dame will be subject to a medical and care needs assessment by the Pilgrimage medical and nursing team. Details will be sent to you along with the acknowledgement of your application. Bookings for the Accueil Notre-Dame remain PROVISIONAL until confirmed by the medical team. If the medical team assess that we cannot meet your medical/nursing/personal care needs your deposit will be returned in full.

For pilgrims applying to stay in a Hotel

Pilgrims must be able to travel independently or be accompanied by someone who can provide for all their care needs. In the event of illness pilgrims will be directed to the locally available medical services. Our medical and nursing teams can not provide care for hotel-based pilgrims. Members of the Youth Team will be available to assist pilgrims with reduced mobility in getting to and from Pilgrimage events.

Please read the information below before signing and returning your booking and deposit.

THE SUPPLY OF TRAVEL AND ACCOMMODATION ARE THE RESPONSIBILITY OF JOE WALSH TOURS, YOUR CONTRACT IS WITH JOE WALSH TOURS.

YOUR FARE is inclusive of direct flights from Belfast to Lourdes (including 1 x 20kg check-in bag and 1 x small cabin bag), transfers from and to Lourdes Airport, courier services, 5/7 nights shared full-board accommodation (single room supplement applies), airport taxes and charges.

CHILD DISCOUNTS: Children under 12 sharing with 2 adults receive a £50 Discount. Infants under 2 years on date of return are charged £50.

CITY TAX: All pilgrims aged 18 or over will be subject to a local government tax (currently €3.60 per person per night.) This tax will be charged directly by your hotel and is payable on arrival at the hotel reception.

CANCELLATION CHARGES: In the event of a cancellation where a pilgrim has opted to purchase our travel insurance, the administration of such cancellation will be handled by Joe Walsh Tours on behalf of the pilgrim in conjunction with the insurance company. Those travelling with their own travel insurance or with a standard Blue Insurance policy purchased through us will be provided the necessary documentation and cancellation invoices to allow them to process their own claims. FINANCIAL PROTECTION: This tour is operated by Northern Star Travel Ltd. Flight inclusive packages originating in the UK are financially protected under the ATOL 11313 held by Northern Star Travel Ltd in compliance with the ATOL scheme administered by the Civil Aviation Authority.

REGULATION (EC) 261/2004: This regulation establishes common rules on compensation and assistance to passengers in the event of denied boarding, cancellation or long delay of flights. The obligations that the regulation creates rests with the operating carrier who performs or intends to perform a flight.
